President's Column

Nigel Bark July 2018

The President's column is always the personal opinion of the WHPS President and not official policy of the WHPS.

This column is a response to the letter published in this issue of Synapse from some members of our Society.

I have relished the opportunity this column has given me to express my personal views about issues directly or indirectly related to psychiatry or that I thought might be of interest to psychiatrists. And everyone is very welcome to write a letter, or their own piece, disagreeing with me and I'm sure our editor will publish it. I speak as a psychiatrist but have never thought that what I say is or could be considered the official policy or view of WHPS. Neither the executive committee nor the membership has ever had any input into what Presidents of the Society have written in their columns.

However, I think we all have taken seriously our roles in writing publicly about issues affecting our profession and our patients, with the general aim of improving services for patients and our ability to provide them. This includes discussing problems that may interfere with these aims and topical issues that may be important to psychiatrists and their patients. And "politics" is having such an effect on our lives, on psychiatric services, on our world view that it cannot and should not be ignored.

My previous columns have discussed Innovation by Psychiatrists; Euthanasia; the Goldwater Rule (twice); Guns, Violence and Mental Illness; Autism, Psychiatry and Pollution; some old and new Epidemiology.

I don't know what the letter writers refer to as the "Goldwater fiasco". I wrote about Goldwater twice because there was serious concern in the country about President's Trump's personality and temperament (lying, impulsiveness, lack of logic, up all night, attention span) and how the experts on personality and temperament should respond. The APA came down firmly on the side of following the Goldwater rule and not responding. One result was that the response of one former APA president was the unedifying and unenlightening "he's a jerk". He also trashed Bandy Lee's book – but I don't think he could have read it. I wrote about Goldwater first generally supporting the rule and later generally against it because I found the book edited by Bandy Lee very helpful and enlightening. But there was no fiasco.

My last column, that the letter criticizes me for criticizing the President, was about progress and hope and the two books demonstrating the enormous progress that humankind has made in the last one or two centuries, including in the area of human rights and respect for minorities. I did mention that President Trump's remarks about immigrants, minorities, gays and the poor were nasty and mean-spirited. I would say that is not opinion, but fact. His nasty and mean-spirited comments about Muslims were called by the courts considering his bans on immigrants from Muslim countries, including the Majority on the Supreme Court, his "animus against Muslims". That Majority chose to ignore that animus – to their shame. (Yes, that is my opinion.) He said

Mexicans are rapists, thieves, animals. Pretty nasty and mean! He said or implied many times Obama was a Muslim, not born in the USA, even as late as 2016. He said blacks in Baltimore were thugs, blacks had no spirit, those "son of a bitch" black players who knelt in protest should be fired. Pretty nasty and mean spirited! Although campaigning he expressed support for gay rights he spent his first year appointing justices and others outspoken against gay rights and his administration banned transgender people from the military, said the civil rights act did not protect gays, and reversed sides on various cases before the courts. Nasty and mean spirited! He has tried to take health insurance away from the 20 million or so who gained it under the Affordable Care Act and when that has not worked he has approved limitations to Medicaid that will reduce its coverage. His Farm Bill will reduce the numbers of very poor eligible for SNAP (food stamps). Nasty and mean spirited!

The two books discussed in my last column were both published this year, and in that column, I did not mention any comments from the books on Trump or the future. Hans Rosling, the author of "Factfulness" died last year and the book was finished by its co-authors, his daughter and son-in-law. There is no mention of President Trump. However, he does list "The Five Global Risks We Should Worry About": Global Pandemic, most likely flu; Financial Collapse; World War III; Climate Change; and Extreme Poverty. To prevent these, we need to strengthen global co-operation and interaction including through, for example the World Health Organization and the United Nations – and have very good data, Rosling says. Trump's policies and attitudes will not help.

Steven Pinker's "Enlightenment Now The Case for Reason, Science, Humanism and Progress" however has a chapter headed The Future of Progress. In it he reviews 11 ways in which "this progress is threatened if Donald Trump gets his way". I will list these here. Life and Health have been expanded by vaccination and access to medical care. Trump has suggested vaccination causes autism and wants to reduce access to health insurance. Worldwide improvements in Wealth have come from the globalized economy and free trade. Trump is reducing that. Growth in wealth has come from technological innovation, education and infrastructure with regulatory constraints on cronyism and plutocracy. Trump is indifferent to technology and education and against regulations. While capitalizing on concerns about **Inequality** he has opposed measures that mitigate it: progressive taxation and social spending. Improvements in the Environment have resulted from regulation, which Trump is disbanding and he doesn't believe in climate change, threatening our future. Safety has dramatically improved, as a result of regulation and evidence-based crime-prevention. Trump is uninterested in both. Post second-world-war Peace has been cemented by treaties, trade, **Democracy** and international agreements. Trump has little regard for these. As mentioned above Trump threatens progress on Equal Rights in his pronouncements and his appointments. The ideal of Knowledge, so vital to progress, is mocked by Trump's repetition of ludicrous conspiracy theories and lies. The Existential Threat of nuclear war is greatly increased by Trump's casual references to nuclear weapons and his abrogation and disrespect for treaties that have limited nuclear weapons over the past 50 years. I think it is my duty to warn of these dangers.

I think it is the duty of all psychiatrists to speak out against measures that reduce mental health services. The APA has done so formally on our behalf on every measure to repeal the Affordable Care Act and to reduce Medicaid benefits.

I wish we had a President who was beyond criticism. But we don't. We have one who lies every day; who is nasty and mean-spirited not just to the poor and weak but to the leaders of our allies,

even while he is being feted and entertained in July while in Britain. I think it is the duty of citizens to speak out against such abusiveness and I will continue to do so.

Letters of Freud & Jung

Syed Abdullah, MD

Below are excerpts from the book, C.G. Jung Word and Image, translated by Krishna Winston; Princeton/Bollingen Series XCVII.2, Edited by Aniela Jaffe; 1979 (pages 58, 60)

"Toward the end of 1912 Jung had begun to formulate his objections to Freud in several sharply worded letters--he referred to them as 'secret letters'. "I shall continue to stand by you publicly while maintaining my own views, but privately shall start telling you in my letters what I really think of you. I consider the procedure only decent. No doubt you will be outraged by this peculiar token of friendship, but it may do you good all the same." (Dec 18, 1912)

Only a few more letters were exchanged before the relationship was terminated. Among them are the following.

Dear Professor Freud,

Although you have evidently taken my first secret letter very much to heart or very much amiss, I cannot refrain, while avoiding that topic, from offering you my friendly wishes for the New Year. It is my hope that the psychiatric movement will continue to advance, its vitality unimpaired and indeed heightened by internal conflicts and cross-currents. Without them there is no life. When everything goes smoothly, petrification sets in. "I seek salvation not in rigid forms."

Don't hesitate to tell me if you want no more of my secret letters. I too can get along without them. Needless to say I have no desire to torment you. But if you profess a friendly attitude towards me, I must insist on my right to reciprocate, and shall treat you with he same analytical consideration which you extend to me from time to time. You surely know that the understanding of truths is in dire proportion to the progress one has made in oneself. If one has neurotic symptoms there will be a failure of understanding somewhere. So if I offer you the unvarnished truth it is meant for your good, even though it may hurt. I think my honorable intentions are perfectly clear, so I need say no more. The rest is up to you.

From the drift of this letter you will be able to guess what my wishes are for the New Year. With best regards, Most truly yours, Jung

Dear Mr. President,

Dear Doctor,

...Accordingly, I propose that we abandon our personal relations entirely. I shall lose nothing by it, for my only emotional tie with you has long been a thin thread--the lingering effect of past disappointments--and you have everything to gain, in view of the remark you recently made in Munich, to the effect that an intimate relationship with a man inhibited your scientific freedom. I therefore say, take your full freedom and spare me your supposed 'tokens of friendship.' We are agreed that a man should subordinate his personal feelings to the general interests of his branch of endeavor. You will never have reason to complain of any lack of correctness on my part where our common undertaking and the pursuit of scientific aims are concerned, I may say no more reason in the future than in the past. On the other hand, I am entitled to expect the same from you. Regards, Yours sincerely, Freud

Jung's answer:

Dear Professor Freud,

I accede to your wish that we abandon our personal relations, for I never trust my friendship on anyone. You yourself are the best judge of what this moment means to you. 'The rest is silence.' Thank you for accepting Burrow's paper. Yours sincerely, Jung

In contrast to Freud, who after the break hardly ever mentioned Jung's name again, except for a sharp attack in his "On the History of the Psycho-analytic Movement" (1914), Jung was neither willing nor able to

draw a final line under the issues raised by their relationship. His works and his letters contain repeated references to his former mentor."

Center for Workplace Mental Health Seeking Input on the Work Function Assessment Process

Psychiatrists are often called on to complete work function assessments for their patients seeking disability benefits. Many employers and disability claims' administrators use multi-page forms that require mental health practitioners to share extensive treatment records and sensitive and confidential information, not all of which is necessary for a work function assessment. In response, the APA Foundation and Center for Workplace Mental Health created a <u>Work</u> <u>Function Assessment Form</u>, which streamlines the process while using a functional impairment scale that comprehensively identifies an employee's ability to perform his or her job. A short<u>survey</u> is available to provide feedback on the form.

I am a member of the listservs of Columbia University and multiple PsychoPharm listservs. I receive Amadeo on 4 different topics http://m.amedeo.com and Evidence Alerts http://plus.mcmaster.ca/EvidenceAlerts/ for reviews of recent articles. I pay for The Medical Letter. I read APA News, Psychiatric Times and Clinical Psychiatry News. I sometimes will read Psychiatric Annals as well. I use Epocrates, Google, Wikipedia, WebMD and others daily. As a result of our modern digital resources, I'm thinking of throwing out all the ancient textbooks taking up space on my shelves. I'd be interested in hearing from others about what resources you rely on to keep up to date.

GoodRx – a plug for this service I have found useful for patients whose medications are not well covered by their insurance. Sometimes it provides very beneficial coupons and lists the least expensive retail source for a medication.

Also, one of our members posted to an international list-serv with regard to any denial of benefit, so I quote Dr. John Fogelman:

The URL below will direct you to a database for the regional CMS (Centers for Medicare and Medicaid Services) headquarters. The names of the regional Medical Directors are listed. When you call, hang in through all the options, and at the end type in the name of the medical director. You will get either the real live doc, an assistant, leave a message, or the name of someone to call for in an emergency. It usually works.

My experience has been that the higher you go in any organization (hospital, government, insurance companies), the closer you are to the decision maker, and the decision makers do not have to stay on the unvarying mindless script. They do not instruct you to have a good day, apologize for your inconvenience, thank you profusely and hear how they know how valuable your time is. They usually listen, and if you do not scream at them, a favorable result often follows.

PARITY ENFORCEMENT FROM NYSPA: If you missed the NYSPA Webinar on parity I strongly suggest you listen to it; accessible on the NYSPA website. Seth Stein and Rachel Fernbach have presented a packet of wonderful new tools that potentially will allow us to better manage and respond aggressively to insurance company efforts to restrict care. **THIS IS IMPORTANT!** NYSPA is soliciting detailed information on insurance reimbursements to identify fee and reimbursement discrimination in the payment for outpatient mental health services. **The NYSPA Parity Enforcement Project (PEP)**

NYSPA is rolling out its newest Parity Enforcement Project initiative to identify fee and reimbursement discrimination in the payment for outpatient mental health services. NYSPA has prepared two Request Forms - one for in-network services and one for out-of-network services - and a set of instructions for using the Request Forms. You will note that the instructions have been prepared for use for non-psychiatrists because these forms can be used by anyone who has health insurance through a job, through ACA or a Medicare or Medicaid managed care plan. We urge every psychiatrist who has health insurance coverage to submit either an in-network form or both forms (if you have out-of-network coverage). Anyone with health insurance can submit the forms regardless of whether they have received, are receiving or expect to receive treatment for mental illness. The forms do not require the disclosure of any individual medical information and the responses will not include any medical information. These forms can be widely disseminated to individuals receiving treatment and support groups for patients. The key is that NYSPA needs to review the responses in order to identify evidence of discriminatory coverage. The forms can be downloaded from the NYSPA website by <u>clicking here</u>. Please join us in participating in this effort to identify and root out reimbursement discrimination in the treatment of mental illness.

PLEASE MAKE EVERY EFFORT TO RETURN PHONE CALLS. EVEN IF YOU HAVE NO ROOM IN YOUR SCHEDULE FOR NEW PATIENTS: I have frequently heard complaints about patients leaving voice mails with psychiatrist's offices and never getting a return phone call. If true, this reflects very poorly on our profession.

Mandatory Prescriber Education in NY after 7/1/17

Prescribers licensed in New York to treat humans and who have a DEA registration number to prescribe controlled substances, as well as medical residents who prescribe controlled substances under a facility DEA registration number, must complete at least three (3) hours of course work or training in pain management, palliative care, and addiction by July 1, 2017.

Practitioners must notify the Department of Health that they have completed the educational requirements by submitting an attestation online.

The Clinical Research Division (CRD, Director: Dan V. Iosifescu, MD, MSc) at the Nathan Kline Institute is pleased to announce we are starting several clinical trials in patients with major depressive disorder (MDD). Our first study is testing transcranial laser therapy (TLT) in addition to antidepressants for MDD subjects who have failed to improve with antidepressants alone.

TLT involves a non-invasive and invisible beam of light that increases energy metabolism in the brain, and some of this increased brain activity may help people with depression. This treatment is not the same as electroconvulsive therapy (ECT).

All TLT sessions will take place at the Nathan Kline Institute. The visits include 1 initial screening visit, 24 TLT sessions, and 1 follow-up visit making for a total of 26 visits to our program. Those who qualify will receive the experimental treatment, study-related, medical exams, and laboratory tests at no cost. Study participants will be compensated \$50 per study visit.
